JOB PROFILE: Executives will be required to post Ads on various Free Classified Ad Sites on the NET on behalf of HYLINE MANAGEMENT SERVICES or on behalf of its clients, according to periodic instructions to be issued by the Management. All Ad postings are to be done manually & record of each posting maintained. No software to be used for posting of ads. Executives must work themselves.
